AGREEMENT

NOW THIS AGREEMENT WITNESSETH THAT:

 2. **Duration:** Either party may terminate this agreement at any time, without any reason by giving a notice of 1 month to the other party.
 3. **Discounts:** As our valued patron, we would like to offer you the below mentioned discounts on "Prevailing Hospitals Schedule of Charges"






