

MEMORANDUM OF UNDERSTANDING

The two organisations will:

- a) Cooperate in the exchange of information relating to their activities in training and placement assistance of students in fields of mutual interest.
- b) Promote appropriate courses of study, with particular emphasis on Drug Regulatory, Pharmacovigilance, and Medical Coding courses.
- c) Endeavour to encourage students and staff to spend periods of time in the host institutions.
- d) Conduct short courses, give presentations, etc., as mutually agreed in writing between the two parties prior to commencement of any such activities.
- e) Conduct marketing activities in the host institution as mutually agreed in writing between the two parties prior to commencement of any such activities.
- f) Conduct study tours, as mutually agreed in writing between the parties prior to commencement of any such activities, wherever feasible




- g) Conduct practical training to students, as mutually agreed in writing between the parties prior to commencement of any such activities.
- h) Conduct placement assistance for students, as mutually agreed in writing between the parties prior to commencement of any such activities.
- i) The institute shall be allowed the ACPL to conduct a minimum of two seminars in an academic year as mutually agreed in writing between the parties prior to commencement of any such activities.
- j) The institute will provide the facilities for conducting above mention point no (i) activities. The ACPL takes care of the travelling arrangements for the speakers and registration formalities for the participants.
- k) The ACPL can participate or conduct a job fair for the fresher's as per the requirement of the pharma industry in an academic year, as mutually agreed in writing between the parties prior to commencement of any such activities.
- l) If the institute is not supporting point no. i, j, k, continually for two years, this MOU will get suspended, and a new MOU shall be prepared as per the mutual understanding.

The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and it forms no legal or financial obligation on the part of either party. The MOU shall be subject to periodic review by both Institutions.

This agreement will take effect from the date of its signing and shall be valid for an unlimited period from that date unless sooner terminated, revoked, or modified by mutual written agreement between title Parties, and may be extended by mutual written agreement.

Either party may terminate the Agreement at any time during the total term by the provision of 30 days written notice to the other party.


